
BEN RICH is a lecturer in international relations, security studies and Middle East politics at Curtin University, Western Australia. His research focuses on Persian-Arabian Gulf geopolitics, terrorism and political violence and the use of identity in authoritarian governance.

The Case of the Saudi State

Why has the relationship between the state and the Islamic revivalist movement known commonly as 'Wahhabism' persisted under Saudi rule since 1744? In Securitising Identity Ben Rich traces the symbiosis between these two entities across three distinct periods of Saudi rule over the past four centuries, showcasing the consistent conditions, patterns of behaviour and political logics that surround their interplay. Collectively, these reveal a recurrent tendency in which the state paradoxically offers protections to the preservation of revivalism while generating threats against this same religious identity in order to ensure its hold on power. Such a pattern, he argues, not only transcends all discrete periods of Saudi rule, but also manifests regardless of the conservative or progressive nature of a particular administration. Understanding such a pattern not only helps to explain why Saudi Arabia today remains a source of regional sectarianism, but also how such an idiomatic ideology has endured in the face of high modernity and why the state it is likely to struggle in its ongoing quest to open itself further to a diverse and pluralistic world.


Muslim and Arab Men in Australian Crime Drama

Heroes, Villains and the Muslim Exception explores recent crime drama film and television depictions of Arab and Muslim men in Australia. It examines the representation of three Australian productions: East West 101, The Combination and Cedar Boys. Since 2007 Australia has seen a notable increase in the inclusion of Arab and Muslim male characters in various serials and films, but what do these inclusions mean for the place of Arab and Muslim men in Australia today? This book seeks to understand how these representations are constructed and whether they are as progressive and edgy as producers and media responses would suggest. This book explores the extent to which cultural productions such as East West 101, The Combination and Cedar Boys open up a space for new understandings of the place of Arab and Muslim Australians in contemporary Australia. Importantly it considers the role of the Special Broadcasting Service in the plight of anti-racism.


Struggling for Equality of Citizenship

Research shows that Indian Muslims experience higher levels of development and equity deficits. Indian Muslims are also predicted to become the largest Muslim population in the world by 2050. This increase in numbers might exacerbate their relative deprivation, creating a disjunction between India's constitutional promises of 'equality of opportunity' for citizens of a secular democracyincluding for minorities—and the existential reality. This will create social and political conditions that could undermine the stability of the country's democracy and make Indian Muslims a security threat, which would have not only national but also global ramifications. This book examines the struggle for equality of citizenship of Indian Muslims in light of the release of the Sachar Committee report of 2006, which sparked widespread awareness of socioeconomic disparity and exclusion of religious minorities in India, especially Muslims. The contributors are some of the most eminent social scientists in the fields. of applied economics, politics, sociology and demography who work on Indian issues.

The Indian state and its political infrastructure have been relatively successful thus far in countering the challenges presented by the diversity of its population. India therefore has the capacity and the ability to deal with these new challenges, given the political and collective will.


POSSIBLE SPACES OF SOMALI BELONGING



IMAM SAMUDRA'S REVENGE



ANGUS MCINTYRE is an Honorary Associate at La Trobe University and a Visiting Fellow in the Department of Political and Social Change at the Australian National University. In the years 2009-2012, he worked with colleagues on an Australian Research Council Discovery Project concerning the origins and development of Islamic terrorist behaviour in Indonesia. His contribution to this joint endeavour eventually took shape as this work.

On the evening of 12 October 2002 two suicide bombers detonated bombs inside Paddy's Pub and in front of the Sari Club in Kuta, one of Bali's main tourist districts. Two hundred and two people were killed including eighty-eight Australians and thirty-eight Indonesians.

The 'field coordinator' of this terrorist operation was the Bantenese Abdul Aziz alias Imam Samudra, who was later executed for his role in the attacks.

Imam Samudra's Revenge examines why Samudra bombed nightclubs in Bali paying due regard to the social and political context provided by both his experiences as a youthful member of the Darul Islam movement in Indonesia and Pakistan, and the outbreak of religious violence in Indonesia from 1999. Yet these same factors also influenced his colleagues within the extremist Islamist group Jema'ah Islamiyah, and they strongly disapproved of his actions in Bali. Therefore, it is also important to consider Samudra's personality; and, more particularly, his proneness to humiliation which led him via the vengeful ideology of global jihadism to embrace terrorism in Bali.


Ten years after the Cronulla riots, the violence, racism and branding of young bodies with signs and symbols of Australian nationalism, along with the reprisal attacks by Lebanese-Australian youth, continues to inflame discussions about race relations in Australia, with many conversations shifting away from ideas of multiculturalism and cultural diversity towards patriotism, localism, security and fear of the (predominantly) Muslim 'Other'.

Battle for the Flag contextualises and challenges the narrative by drawing upon participant observation and interviews conducted with local residents of diverse backgrounds. By paying attention to the voices of bystanders and those involved, the riot is identified as an unstable and fluid formation, where the Australian flag, the beach and whiteness itself was co-opted into a much more contingent, contested and subcultural formation than hitherto described.



To Recognise Or Not To Recognise


In recent years, all over the western world, a conversation has begun about the role of Islamic law or Shariah in secular liberal democratic states. Often this has focused on the area of family law, including matters of marriage and divorce. *Islamic Family Law in Australia* considers this often-controversial issue through the lens of multiculturalism and legal pluralism. Primarily, its main objective is to clarify the arguments that have been made recently.

In both Australia and overseas, debates have occurred which have been both controversial and divisive, but have rarely been informed by any detailed analysis of how Muslim communities in these countries are actually dealing with family law issues. *Islamic Family Law in Australia* responds to this need for accurate information by presenting the findings of the first empirical study exploring how Australian Muslims resolve their family law matters. Through the words of religious and community leaders as well as ordinary Australian Muslims, the book questions the assumption that accommodating the needs of Australian Muslims requires the establishment of a separate and parallel legal system.

In 2005, the Australian Federal Police referred eight Islamic books to the Australian Classification Board. The goal was to secure a ban of the books, all of which were alleged to advocate 'terrorist acts'. After nearly a year of review, and intense public debate, two of the books were refused classification and effectively banned in a move that would have severe repercussions for librarians, scholars, authors and the state of free speech in Australia.

Banning Islamic Books in Australia examines the cultural and political contexts that led up to the ban, and the content of the books themselves in an attempt to determine what it was that made them seem so dangerous. It also documents the unintended consequences of the ban on library collections and academic freedom, and how this in turn affects free speech in contemporary Australia.





The Dynamics of Exclusion and Inclusion

Muslims in Australia have attracted increased attention as citizens in the last decade. The research scholars in this book present a complex and dynamic picture of their presence and experiences in Australia, taking us far beyond simplistic notions of security threats and discrimination.

Despite these adverse conditions, Muslim women have demonstrated a remarkable resilience by maintaining their presence in the public domain and by continuing to make a positive contribution to Australia. The experiences of Muslim women in Australia cannot be typecast as a sisterhood of oppressed females.

Challenging Identities questions the assumption of incompatible 'Australian values' and 'Islamic values', and provides valuable first-person accounts from the lives of Muslim women in Australia.




