Research Recognition

A big congratulations to Arif Saba and Neda Zeyghami for completing their PhDs. We are very proud of their remarkable achievements. 2023 was also a great year of recognition for Dr Abbas Farasoo, who completed his PhD in 2022 on 'The Impacts of Proxy War on Afghanistan' at Deakin University. Dr Farasoo won the 2023 Australian Political Studies Association PhD Thesis Prize which is awarded annually to the best PhD dissertation in political science. The year only got better with announcement of national field leaders:

MESF Events

2023 saw seven main events hosted that year. The year started with "Everyday Choices: The Role of Competing Authorities and Social Institutions in Politics and Development" in March with Prof Ellen Lust (University of Gothenburg).

A seminar was held in May by Dr Niamatullah Ibrahimi (La Trobe Uni) on "A Violent Nexus: Religious Fundamentalism, Exclusionary Nationalism, and the Taliban." In May was also the biggest event of the year, a three day workshop as part of our research project 'Emerging digital technologies and the future of democracy in the Muslim world', funded by Gerda Henkel Foundation.

In August we held an in-person seminar by Dr Mariam Farida (Macquarie University): "The Weaponization of Religious Myths: An Ethnography Shi'ite Gendered Narratives".

As part of Social Sciences Week in September, MESF co-hosted a panel discussion on Australia's Relations with the Middle East. This event was held jointly with the Australian Institute of International Affairs (AIIA) and included representation from the Department of Foreign Affairs and Trade (DFAT) Middle East Division. The event explored Australia's evolving ties with the Middle East post its military withdrawal from Afghanistan in 2021. Emphasizing the enduring cultural, economic, and geopolitical importance of the region, the discussion focused on how factors such as increased migration, growing trade, and geopolitical shifts impact Australia's interests.

At the end of October we held our final seminar of 2023 with Dr. Hadeel Abdelhameed on "Politics of Grief: Mothers and Protesters".

Our final even of the year was a joint GDP & MESF Hybrid Workshop titled "Strategic Digital Information Operations, Democracy and Social Cohesion." This workshop emerges from a research endeavour supported by the Gerda Henkel Foundation through the Democracy funding scheme. The project, led by a consortium of scholars from Deakin University, saught to investigate the methodologies employed by state and non-state actors in deploying strategic digital information operations.
